# First Nations Leadership Council

The FNLC, or First Nations Leadership Council, is a collaborative political partnership in British Columbia. It brings together the BC Assembly of First Nations, the First Nations Summit (FNS), and the Union of BC Indian Chiefs (UBCIC) to advocate for and support the interests of First Nations in the province. It is mandated to develop high-level strategies and actions to bring about unified change in government policy in a collective effort to improve the lives of all B.C. First Nations citizens.




The BCAFN is a Provincial

# Key Sectorial Areas

First Nations are disproportionately affected by the cliate emergency. The FNLC, as mandated by and in collaboration with First Nations in BC, launched the BC First Nations Climate Change Strategy and Action Plan 2022.


The Strategy and Action Plan encourages First Nations communities from all regions of the province to put forward recommendations for climate action that align with First Nations' values, worldviews, and priorities.

### Overview

- In 2019, Chiefs in BC mandated the FNLC to prepare a draft First Nations Climate Strategy and Action Plan
- The Strategy was endorsed in 2022 as a living document
- accompanied by an Executive Summary and
   20 Urgent Calls for Action
- Comprehensive and province wide in scope
- Respects diversity and self-determination of First Nations, but also seeks to respond to the needs and priorities of First Nations in BC as a collective body.

Resolutions: UBCIC/No. 2022-04; BCAFN/No. 06/2022; and FNS/No. 0222.06





# What is the Strategy?

As mandated by the First Nations Leadership Council's Resolutions, the strategy had to:

- Align with UN IPCC recommendations on GHG emission reductions
- Strengthen First Nations climate leadership to reduce vulnerabilities
- Seeks to address the climate crisis and its impacts on First Nations in BC
- Co-created with First Nations and grounded in Indigenous knowledge, laws, and worldviews
- Upholds self-determination and Title, Rights, and Treaty Rights

### Vision

We, the first peoples of the lands, assert our inherent Title Rights, and jurisdiction to lead the response to the climate crisis. We exercise our knowledge, laws, and processes in our self-determined ways to care for the Earth and ensure health and stability for future generations.

## Four Pathways

- Inherent Title and Rights
- Capacity and Leadership
- Land and Water Protection
- Climate Response and Preparedness











- 2023 was the worst wildfire year in BC's history. In 2024, BC has continued to experience significant climate change impacts, particularly wildfires, floods, and droughts.
- The total economic costs associated with the 2021 heat dome, floods, wildfires and landslides were estimated between \$10.6 to \$17.1 billion.
- The interconnected climate and biodiversity crises pose a dire threat to the survival, culture and ways of life of First Nations.
- The climate crisis is outpacing B.C.'s and Canada's ability to adapt. This crisis is exponentially affecting First Nations and their territories.
- There is an inherent disconnect between colonial climate policy and First Nations Worldviews.

# Paddling Forward with One Heart and One Mind

- Built on the BC First Nations Climate Strategy and Action Plan and other foundational First Nations climate engagement and work.
- Reflects localized needs & priorities elevated to the provincial scale
- Developed to enable transformational change in the federal system to:
  - Empower First Nations' meaningful involvement in national climate governance; and
  - Uphold First Nations' self-determination and inherent rights and foster community-based climate leadership.


It is essential to ground the BC FNCL Agenda work and the implementation of the BC First Nations Climate Strategy and Action Plan in Ceremony and with guidance from the Knowledge Keepers.

"We have to continue this dialogue without creating mroe silos. We have to do ceremony. More ceremony, less silos. We must each do our own work so that we can work together. I am able to dream again."

### Knowledge Keepers' Mandate

- Restore First Nations responsibility for the Land through selfdetermination, jurisdiction and self-governance.
- Revitalize and exercise language, culture and Ceremony and share our worldview for the benefit of all beings.
- 3. Revitalize and strengthen Sacred and Natural Law.
- Validate Traditional/Indigenous Knowledge.
- Recognize that Climate Change is the inevitable result of the disconnect from the teachings of Natural Law.
- 6. Promote healing, starting with individuals.
- Respect women and 2SLGBTQQIA+ peoples. What is happening to them is tied to what is happening to the Land.
- Promote safety, connection and belonging for men so that they can continue to contribute to healthy systems.
- Make decisions with Seven Generations in mind. Create a paradigm shift that re-establishes ecosystems' inherent value, not their value as resources.
- 10. Protect the Waters and the salmon.
- 11. Rebuild relationships with each other and the Land.
- 12. Prioritize the education of our youth; break intergenerational cycles and remind them of their purpose.
- 13. Our Nations must stop working in silos.
- 14. People of all four directions must take ownership and responsibility for their actions and work with First Nations to create a new path forward in relationship with Mother Earth.

- BC FNCL Agenda report was formally endorsed by the BCAFN Chiefs-in-Assembly via Resolution 05/2025










# Unique Opportunity for Action

- The BC FNCL Agenda's high-level recommendations are presented as a web of interconnected recommendations to enable transformational change.










## Relefections and Lessons Learned

- Short timelines and lack of sufficient budget for engagement. Important for the government to go to the 204 Nations and build meaningful relationships.
- Issues with lack of transparency and misalignment with the colonial ways of working.
- The immense complexity of the federal machinery.
- Lack of a clear path to full implementation. Accountability mechanisms?
- Transformational change requires a longterm commitment beyond the political agendas and election cycles.







We Mirror What We See

- Climate anxiety is real. Healing and ceremony are essential. "The health of the land is a reflection of the health of the people."
- There is a lack of urgent climate action by crown governments. We need self-determined solutions that are grounded the are feasible and action.
- Two eyed seeing and bridging the gap between colonial policy and First Nation worldviews.
- Breaking silos and working together is essential.
- Important to look at First Nations climate action and environmental justice from a different lens.
- Relationships are central to climate action.



# Climate Capacity Assessment

- Working with Coastal First Nations Great Bear Initiative (CFN-GBI) and Pinna Sustainability
- Focused on assessing disparities among communities in their capacity to respond to the climate crisis and participate in provincial climate change decision-making.
- Identify needs, barriers, and challenges that limit the implementation of self-determined climate change actions.
- Key activities include Research, a Survey, Engagement,
   Analysis and Final Report

Goal: Ensure First Nations in BC are empowered and prepared with the capacity and tools needed to effectively lead the response to the climate crisis both now and in the future.
